HOW TO APPLY

ENTITIES CAN APPLY TO BECOME A FRIEND OF EFRAG BY COMPLETING THE ONLINE APPLICATION FORM [HERE](#), PROVIDING A DESCRIPTION OF THEIR MISSION AND ACTIVITIES AND A MOTIVATION STATEMENT IN SUPPORT OF EFRAG' MISSION IN ITS FINANCIAL REPORTING ACTIVITIES.

APPLICATIONS SHOULD BE COMPATIBLE WITH EFRAG'S MISSION, NOT IMPAIR THE INDEPENDENCE OF EFRAG OR CAUSE CONFLICT OF INTERESTS. BECOMING A FRIEND OF FRIEND OF EFRAG INVOLVES AN ANNUAL CONTRIBUTION OF A MINIMUM OF €5000. ORGANISATIONS ARE ENCOURAGED TO PROVIDE A HIGHER AMOUNT CORRESPONDING TO THEIR PROFILE, SIZE AND FOOTPRINT. THE EFRAG GENERAL ASSEMBLY DECIDES ON THE ADMISSION AS FRIEND OF EFRAG AND CAN WITHDRAW THE ADMISSION WHEN THE ABOVE CONDITIONS ARE NO LONGER MET.
